The aim of this request is to hire an Event Management firm as consultant, to conduct/hold the National Youth Carnival (NYC-2021).


Sealed bids are invited for conducting/holding the NYC-2021 from well-established/ reputed consultancy firms registered with tax authorities i.e. FBR and KPRA and other relevant authorities. Tender Documents containing bidding procedure, terms & conditions, scope of work, and technical specifications can be obtained from the office of undersigned during office hours on or before 05/11/2020 till 12:30 pm against non-refundable cash payment of Pak One Thousand (Rs. 1,000/-). The system of selection would be Quality and Cost Based Selection (QCBS) under KPPRA Rules whereas the method of procurement shall be single stage two envelopes method. The bid shall be a single package containing two sealed envelopes separately, marked in bold and legible letters as Technical and Financial Proposal.

Bids should be submitted on or before 05/11/2020 at 02:00 pm.
Bid security i.e. 2% of total value of the bid amount in the form of bank draft/ call deposit in favour of Director Youth Affairs Khyber Pakhtunkhwa must be attached with the Financial Proposal and undertaking on the surety bond of Rs. 100 of the 2% bid security must be attached with the Technical Proposal.

Bids will be opened on the same day i.e. November, 5th 2020 at 02:30 pm in the presence of the bidders or their authorized representatives, in the Conference Room of the Directorate of Youth Affairs Khyber Pakhtunkhwa, Peshawar on the above cited date and time. Late and incomplete bids will not be considered and will be rejected. The Directorate reserved the right to reject any or all bids as per provisions contained in Rule-47 of KPPRA Procurement Rules, 2014.
