No. SO (YA) Y-4/Misc./2022/4292 --- In exercise of the powers conferred by subsection (2) of section 10 read with sub-section (3) of section 4 of the Khyber Pakhtunkhwa Youth Affairs Management and Disposal of Immovable Properties Act, 2019 (Khyber Pakhtunkhwa Act No. IX of 2019), the Government of Khyber Pakhtunkhwa is pleased to make the following rules, namely:

THE KIIYBER PAKHTUNKHWA MANAGEMENT OF YOUTH HOSTELS RULES, 2021.

Part-I Preliminary

- 1. Short title and commencement.---(1)These rules may be called the Khyber Pakhtunkhwa Management of Youth Hostels Rules, 2021.
 - (2) These rules shall come into force at once.
- 2. **Definitions.---(1)** In these rules, unless the context otherwise requires,-
 - (a) "Act" means the Khyber Pakhtunkhwa Youth Affairs Management and Disposal of Immovable Properties Act, 2019 (Khyber Pakhtunkhwa Act No. IX of 2019);
 - (b) "hostel warden" means the official of the Directorate, to be appointed or designated as such, for the purpose of looking after the affairs of youth hostels;
 - (c) "Province" means the Province of Khyber Pakhtunkhwa;

- (d) "youth" means youth, as defined in clause (h) of section 2 of the Khyber Pakhtunkhwa Youth Welfare Endowment Fund Act, 2019 (Khyber Pakhtunkhwa Act No. XXVI of 2019); and
- (e) "youth hostel" means the youth hostel established under rule 3 of these rules.
- (2) Words and expressions, used but not defined under these rules, shall have the same meanings as are assigned to them in the Act.

Part-II Establishment of Youth Hostel its Management and Accommodation

- 3. Boarding, lodging and fee for accommodation in youth hostel.--- (1) Government may establish such numbers of youth hostels as it may deem appropriate which shall provide such boarding and lodging facilities to the youth, as Government may determine, from time to time, with the sole objective that such accommodation shall be for the comfort and convenience of the youth.
- (2) The accommodation in the youth hostel shall be subject to payment of such nominal fee, as the Directorate may, from time to time, determine.
- 4. Appointment, designation of hostel warden and officials.---(1) The management of the youth hostel shall consist of a hostel warden and such other necessary staff, as the Directorate may, from time to time, require.
- (2) The hostel warden and the other officials shall be appointed by the Directorate for each hostel, on such terms and conditions, as may be laid down in accordance with sub-rule (2) of rule 3 of the Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion and Transfer) Rules, 1989.
- (3) The hostel warden shall act as incharge of the youth hostel and for running its day to day affairs and shall reside in the youth hostel.
- 5. Accommodation procedure.---(1) A youth, who intends to stay in the youth hostel, may apply to the hostel warden, through written application, which shall be accompanied by a copy of his CNIC, From-B or any other identification documents, as the case may be, and such fee, as the Directorate may determine under sub-rule (2) of rule 3 of these rules.
- (1). Shall does submit such other information as the hostel warden may deem acknowledgement receipt, which shall be sufficient proof for his stay in the youth an hostel.

- (3) The hostel warden shall maintain a register having complete record of all the youth, to whom rooms, in the youth hostel, have been allotted.
- 6. Depositing of income.—(1) The income, arising out of the admission fee, shall be deposited by the hostel warden with the Drawing and Disbursing Officer of the Directorate and such Drawing and Disbursing Officer shall further deposit the same in the designated bank account, maintained in the Bank of Khyber, which shall be credited to the Fund, in terms of sub-section (2) of section 3 of the Act.
- (2) The income, so credited to the Fund, may be utilized for the maintenance works, carried out in the youth hostels, under clause (d) of sub-section (1) of section 4 of the Act.
- 7. Conditions of allotment of room.—(1) The youth hostel management shall generally provide minimum furniture and fittings for each room, in the youth hostel, consisting of one each of cot, table, chair, ceiling fan and a tube light fitting.
- (2) Room may be allotted for such period as requested by the youth in his application or as the hostel warden may deem appropriate.
- (3) The youth hostel management, in case of restricted number of rooms, may accommodate two or more youth in one room.
- (4) The hostel warden may, where he deems appropriate, cancel the allotment of room in the youth hostel.

<u>Part-III</u> Miscellaneous

- 8. Code of conduct.—(1) The youth, who are allowed in the youth hostel, shall maintain standard of behavior and follow such other instructions, as issued by the hostel warden, from time to time.
- (2) The youth are required to carry the acknowledgement receipt with himself, issued to him by the hostel warden, and shall produce the same on demand by the youth hostel management.
- (3) The rooms, common areas and surroundings shall be kept clean and hygiene. Notices shall not be pasted on walls and the walls shall not be scrubbed on.
- (4) The instructions, with regard to schedule of timings, issued by the hostel warden, shall be complied by the youth.
- (5) The youth shall immediately brought into the notice of youth hostel management about any civil, earpentry or electrical work that are required to be carried in his room.

- (6) The youth shall co-operate with the youth hostel management in carrying out maintenance work and vacate the room completely when it is required for repair or any other purposes. On such occasion the youth hostel management may provide alternate accommodation, if available or may accommodate them under subrule (3) of rule 8 of these rules.
- (7) The youth shall be responsible for any damage, caused to the property in the room, inside the youth hostel, during his occupancy, and he shall be required to make good the damage.
- (8) The youth shall fill in the inventory of the furniture and other items available and handover the furniture and other materials in good condition when he vacates the room in the youth hostel.
- (9) The youth shall not be allowed to remove any fittings from any other room and get them fitted in his room and remove from his room and get them fitted in any other room, as the case may be.
- (10) Smoking and consumption of alcoholic drinks or narcotics drugs, in the youth hostel premises, shall strictly be prohibited. The youth shall not be allowed to enter the youth hostel premises in intoxicated state.
- (11) The youth shall not be allowed to bring with himself arms and ammunition in the youth hostel.
- (12) The youth shall not be allowed to accompany himself such other outsider, who has not been mentioned in the application form, at the time of allotment of room in the youth hostel:

Provided that such outsider may be allowed with prior permission of the hostel warden.

- 9. Use of appliances.——The use of electrical appliances such as electric heaters, electric stoves are prohibited. Private cooking in the hostel room shall also be prohibited and if such appliances are found in the room, it shall be confiscated by the youth hostel management.
- 10. Responsibility of personal belongings.—The youth shall be personally responsible for the safe keeping of their personal belongings and shall ensure to keep all valuable items in lock and in case of any theft, shall promptly report to the hostel management.

- 11. Hostel mess.—There shall be a hostel mess or canteen from where a youth can avail food on such prices as the hostel warden may fix from time to time.
- (2) The hostel warden shall ensure that the quality food shall be provided in the youth hostel.
- (3) The youth hostel mess shall remain open and serve the services at such timing and in such manner as the hostel warden may, through instructions, deem fit.

 12. Check out.--- (1) At the time of leaving the youth hostel, the youth shall inform the reception of the youth hostel and before he leaves, the youth hostel management shall ensure that the room allotted to him is found in good condition and

no damage has been done to the room.

(2) The hostel warden, after being satisfied, collect from the youth the key of the room and shall handover to him his CNIC, in original, if collected from him at the time of allotment of room.
