MINUTES OF COMMITTEE MEETING

Agenda: Opening, Evaluation of Financial Bids and Samples Inspection.

Consequent upon the aforementioned Tender Notice published on the KPPRA and Directorate official websites titled "Procurement of Furniture and Fixture" a meeting was convened in the office Director Youth Affairs Hayatabad Peshawar in connection with opening of Financial Bids of the technically qualified bidders.

1. The following 03 No. of Technically Qualified Bidders participated in the Bidding process: In first phase, the Procurement Committee Members accompanied by Director Youth Affairs and representative of qualified firms, thoroughly inspected all the furniture items of the three Technically Qualified Firms in accordance with specifications given in the Bidding Documents. Subsequently, financial bids were opened in the presence of authorized representatives and the following result was obtained:

1.	M/s Zeeshan Traders (Bannu)	Samples Provided and were found in conformity with required specs	4,573,600/-	1st Lowest
2.	M/s Frontier Works Promoters	Samples Provided and were found in conformity with required specs	4,958,000/-	2nd Lowest
3.	M/s Three Leaves Traders	Only One item (auditorium Chair) was provided and that was not as per specs	--	Bid returned unopened due to non provision of samples of all items

2. The financial bid of firms at S.No 1 and 2 were found responsive whereas M/s Three Leaves Traders bid was non-responsive due to non provision of complete samples and as such the prices/rates quoted by them were announced in the meeting.

3. The Committee recommended of contract for supply of furniture items amounting to Rs. 4,573,600/- (Rupees Four Million Five Hundred & Seventy Three Thousand Six Hundred only) be awarded to M/s Zeeshan Traders (Bannu) being lowest amongst all.

The meeting ended with a vote of thanks.
