- Candidates applying against disable quota will be required to submit disability certificate issued by provincial council for rehabilitation of disabled persons as well as from respective medical superintendent / medical board showing therein the specific disability and both the certificates must be issued before the closing date of advertisement.
- The candidates working in government / semi-government bodies should apply through proper channel.

  After online apply, don't send documents / testimonials to ETEA office, copies of testimonials / documents will however, be provided by the candidates who qualify the screening test, as and when required by ETEA or the Appointing Authority for scrutiny purposes.
