In compliance with Khyber Pakhtunkhwa Public Procurement Regulatory Authority (KPPRA) Act,2012 and Rules,2014, Director Youth Affairs Khyber Pakhtunkhwa, invites bids through E-Pak Acquisition and Disposal (EPADS) Systems (<https://kp.eprocure.gov.pk/>), through National Competitive Bidding from Event Management Firms (having 05 years of Experience in the relevant field) for the Financial Year 2025-26. (Through EPADS) (Under Framework Contract).
2. Bidding competition under this advertisement shall be conducted through **Single Stage-Two Envelopes** Bidding Procedure as per KPPRA Act, 2012 and rules framed thereunder. Under this procedure, the bidders shall submit original bids on EPADS only.

4. Pre-bid meeting with the interested bidders will be held on **Friday, 27<sup>th</sup> March 2026 at 11:00 AM** in accordance with the schedule mentioned in the Bid Solicitation Documents. The bidders shall thoroughly study the Bid Solicitation Documents before the Pre-Bid meeting and bring their queries / suggestions to the forum for clarification/understanding and the same shall be submitted in written before the Pre-Bid meeting. In case of non-submission of hard copy on or before the pre-bid meeting day, the queries / suggestions shall not be considered / entertained.
5. Bidders shall submit original bids **through EPADS** Only on or before **10:30 AM sharp on Friday 3<sup>rd</sup> of April 2026**, which will be opened on the same day at **11:00 AM**. Any bids presented / submitted / received later than this deadline shall not be considered and shall be rejected without any further processing.
6. Quotations with cutting, erasing, and over-writing shall not be accepted to the extent of that particular quoted item.
7. Mandatory Bid Security / Earnest Money amounting to a flat rate of Rupees 200,000/- in the form of CDR permissible under the rule in the name of Director Directorate of Youth Affairs Khyber Pakhtunkhwa is required to be submitted in original from the account of the bidder prior to bid opening, failing which bids of such bidders will be rejected.
8. Bidders are required to offer the most competitive rate of their items, as negotiations on quoted rates are not allowed under the rules.
